Heat Pump Water Heaters (\$500) – Purchase an ENERGY STAR® certified heat pump water heater and receive a \$500 mail-in rebate. This opportunity can cut your water heating bill in half compared to a standard electric model.

Pool Pumps (\$350) – ENERGY STAR certified pool pumps run quieter and prolong the life of your pool's filtering system. These pool pumps are 30-72% more energy efficient than a standard model.

Room Air Purifiers (\$50) – ENERGY STAR certified room air purifiers are 40% more energy efficient than their standard counterparts, so they use less energy to remove dust and pollen from indoor air. Certified room air purifiers must meet energy efficiency requirements based on the electricity used to remove pollutants.
